2. PROGRAM BACKGROUND

Connexions dual diagnosis program seeks to improve the quality of life of young people 16-28 years with complex difficulties associated with mental health and substance misuse. Services include clinical assessment, psychosocial support, assertive outreach, flexible therapeutic counselling, case management, suicide prevention, drug and alcohol interventions, clinical consultancy, advocacy, and information and referral.

Connexions aims to work on the things that are most important to the individual, to improve their quality of life. We do this by understanding and working alongside young people and tailoring support to the individual needs of the young person.

Connexions provides an integrated support response, allowing for tailored support to young people accessing the service. This integrated service response is offered across two sites in Brunswick and Sunshine.

3. KEY OBJECTIVES OF THE POSITION

The key objectives of this position are:

- 3.1 To work collaboratively as a member of the Connexions team to provide medium to long-term counselling, psychosocial support and therapeutic case management support to marginalised young people exhibiting substance misuse and mental health concerns.
- 3.2 To facilitate pathway options for marginalised young people into mainstream mental health, alcohol and drug, other health, welfare, education/training and community services.
- 3.3 To contribute to the ongoing development of Connexions practice standards and service innovation.

4. DUTIES

- 4.1 Undertake individual counselling, assertive outreach and case management with young people who present with substance misuse and mental health concerns.
- 4.2 Facilitate access for marginalised young people to mainstream agencies such as mental health, alcohol and drug services and other community services.
- 4.3 Ensure the maintenance of appropriate files, records and statistics to facilitate evidence-based practice, quality service delivery and accountability.
- 4.4 Develop creative and flexible programmatic responses to maximise accessibility for marginalised young people with long-standing and entrenched barriers to engagement.
- 4.5 Compliance with relevant legislation
- 4.6 Commitment to continuous quality improvement processes
- 4.7 Provide secondary consultation to internal Jesuit Social Services programs and external agencies regarding individual cases.
- 4.8 Provide suicide identification and risk assessments.

- 4.10 Participate in regular network meetings, working groups and forums relevant to the work of Connexions.

- 4.12 Other duties, as required

- 5.3 A sound therapeutic framework and an understanding of psychosocial support, dual diagnosis and family inclusive principles.
- 5.4 Capacity to work well in a team of professionals with a range of qualifications and experience
- 5.5 Capacity to fulfil reporting and administrative requirements associated with the position
- 5.6 Capacity to fulfil reporting and administrative requirements associated with the position
- 5.7 Understanding and sympathy with the mission and ethos of Jesuit Social Services or
- 5.8 Current driver's licence
